3	Chair's Report Paul gave a recap of this year's events: Hidden Gardens had a lower turnout (poor weather forecast). Over 20 gardens opened and gardeners were thanked. Village Show went well although we were let down by the bouncy castle and First Aid – new procedures are in place to avoid this happening in the future. Paul Finch's/Tech Hub's new programme worked very well handling the entries and show day results. Iain Langdon was thanked for enabling the handover. The After Show Party went well and was well attended. The Art Show was less well attended and we welcome ideas for how to use the marquee for the Sunday after the show. The Garden Party tickets sold very quickly and was a fun evening.

Horticultural Society Treasurer's Annual Report for 2024/25

16th November 2025

I am pleased to report that we have had another successful year generally despite making a small loss.

Our overall loss for the year was **£515** and at the financial year end we had £15,608 in our account compared to £16,124 the previous financial year.

This loss was mainly due to increased general costs of £1,872 as we invested for the future. This was largely the purchase of 80 chairs at a cost of £1,140. These were used primarily for the Garden Party as we were told the church had disposed of its old plastic school chairs stored at Keith Birch's barn. Without these chairs we had no way to seat people for the Garden Party! There is, however, another advantage to these chairs, in that we can now hire 80 less chairs for the Village Show and therefore save ourselves that cost.

We had 29 **Patrons**, contributing a total of £2,735 to support our work.

We had 21 **members** in the year.

Hidden Gardens made a reduced net profit of £1,800 (£2,792 last year) after all costs. This was due to poor weather over the weekend and reduced attendees of 279 (418 in the previous year). This simply proves what we have always known, that we are heavily weather reliant for this and the Village Show.

The **Garden Party** made a net profit of £1,153 (almost identical to last year) and was sold out in a few days to 82 people. It was helpful that we gave the Patrons an early opportunity to buy tickets, which they greatly appreciated.

Trips and Talks The three Trips made a surplus of £270 overall with a total of 85 people attending.

The **Village Show** made an overall loss of £1,480 (similar to the previous year) with income of almost £10,000, but expenses of around £11,500. As always, by far the largest cost was the marquee at over £4,000. The bbq made a profit of £1,057 due to the huge efforts of Chris Shemming and friends. We worked with the Football Club for them to run the bar and keep the profits. The marquee attracted over 600 paying adults and we had over 700 entries to the show. However, both these numbers are down on last year (750 marquee visitors and 800 entries)
